
















## INFORMATION ON DATA PROTECTION ADDRESSED TO JOB APPLICANTS

Dear Applicant,

Thank you for your application. We kindly ask you to read carefully the following information in respect of the processing your personal data in your application:

<b>1. Name of the data controller:</b> 	<b>RAGT Vetőmag Kft.</b>  The personal data provided by the applicant will be made available only for employees of RAGT Vetőmag Kft participating necessarily in the selection and recruitment procedure, competent employees having proposal or decision-making power in labour recruitment or - if it is necessary - the data processors indicated in section 9.

Purpose of the data processing:</b> 	The purpose of our data processing is to apply for a job advertised by RAGT Vetőmag Kft, the evaluation of the application, the establishment of an employment relationship and your notification of future job offers, of which are suitable to your qualifications and professional experience according to the viewpoint of RAGT Vetőmag Kft.
<b>5. Scope of processed data:</b> 	RAGT Vetőmag Kft will process the applicants' following data: surname and last name, email address, phone number, postal address, the existence of a work permit in respect of employees from abroad, image, data provided by you, indicated in your CV or in the tender material produced in the selection procedure, including all documents created within the framework of your personal hearing or for the purpose of assessing your ability to perform the job.
<b>6. Legal basis for data processing:</b> 	Your consent, of which is considered as granted by RAGT Vetőmag Kft by submitting your tender material.  It may occur during the job interview that the applicant fills different kind of tests and surveys or participates in situational exercises to set up personality profiles, from which the concerned applicant will be individually informed of its eventual utilization. We will ask the concerned applicant's individual prior consent for the tests to be performed to set up personality profiles.  If the external inspection of the data indicated in the tender material submitted to our company will be required, we will ask the applicant's written prior consent for that in every case.
<b>7. Term of data storage:</b> 	RAGT Vetőmag may process your personal data until you do not request the deletion of your personal data.
<b>8. Data transmission and data processors:</b>	We hereby inform you that RAGT Vetőmag Kft may use data processor during the data processing.
