The scope of the processed data may include the followings: personal identification data, contact data, tax number, social security number, bank account, data on the establishment, performance or termination of contractual relationship required for the performance of obligations in respect of this relationship, status, position, any personal data relating to the management of the business partner, which helps the business relationship established with RAGT.
<b>Legal basis for data processing:</b> 	The consent of the data subject, or the establishment or performance of the contract
<b>Term of data storage:</b> 	In respect of the rights and obligations related to the contractual relationship, we will process your personal data until the termination of the contractual relationship, the expiry of the limitation period of the rights and obligations arisen from the contractual relationship, or until the deadline specified in the legislation on the preservation period.
<b>Data transmission and data processors:</b>	Your personal data will not be transmitted for the purpose of data processing to data processors.
